



- At the current juncture, 16700 levels hold as resistance for the benchmark index Nifty50 below which the index may likely witness down side towards 16700 levels on a broad range. On the lower side, the index may navigate towards 16790 levels, which has seen a significant built down in open interest.
- Technically, the index is having support around the 16500 zone and any sustenance below it may negate the current bearish sentiments in the market and may navigate down in the near future.
- On technical setup, Nifty Banks and Financial Services looks bearish as seen on the intraday chart closing down the support zone.
