- ☐ After a gap up opening today, Nifty surged almost nearer to 14500, forming a long lower shadow candle. Nifty even topped above a trend line that was drawn joining recent top and had been acting as a resistance level.
- ☐ The gains from recent low of 13131 to today's high of 14498 is equivalent to 61.8% of the gains in preceding rally from 11535-13777. This is an important level. If the index sustains higher which looks like in all probability, it could head towards 15000+ over next day.
- ☐ On the lower side, today's rising gap threshold act as crucial support now. Only below that, minor dip can be seen.
