- A small white candle was formed as markets staged a recovery following sharp losses yesterday which was almost expected. However, gaining further ground and sustaining beyond 13000 could be difficult as pressure of profit booking gathers steam
- It looks like that the index could move higher towards 13050-13100 range. Avoid fresh buying at higher levels
- On the lower side, it looks like that 12900-12830 would continue to act as support for the time being.
