- It was an absolutely bad day as markets witnessed heavy selling pressure with all sectoral indices witnessing sharp losses and Nifty plummeting over326 points to end at 10805. Bank Nifty lost another 721 points to end at 3 month low of 20456
- Last six days have been extremely awful as the index corrected sharply, losing almost 800 points. Nifty had a gap down action today, opening at 11015 and went on to plummet to 3 month low of 10790. The sharp losses have ignited fear and panic among investors, specially those who invested in recent midcap rally. While the panic is visible, it also looks like that near term move has extended quiet a lot, turning highly oversold.
- > The 200 MA at 10760 is likely to act as near term support. On violation, the 38.2% retracement level of previous rally at 10665 is next crucial support.
- As the market is taking cues from global peers, any rebound there can help a pullback here as well with 10880 acting as is immediate resistance. Above that 10950 can be seen too
