- > It not only gained but sustained the gains today as Bulls managed to pull the Nifty to fresh 5 month highs at 11401. It ended the day at 11385, gaining 138 points
- > The lower trend line passing through 11100 provided fresh strength and vigor to the bulls as they pounced on the markets to pull bank Nifty to fresh 5 month highs
- A big white candle was formed today following yesterday's Long lower shadow candle. With Bank Nifty too bouncing back strongly, the momentum is back. For past couple of week, 11370 has turned out to be a resistance level, but today's higher closing marks the resumption of the trend following 4 week of consolidation
- Nifty is expected to open higher tomorrow and then move towards 11450-11550 range. Over course of next few days, a breakout past crucial 11550 may even push the index towards 11700 and higher
- > On the lower side, 11370-11340 acts as strong support level. Any minor dip should be used to enter fresh long positions.
