

- Landslide victory for the BJP and NDA put the markets into a new orbit as all frontline indices zoomed to new highs. Sensex crossed 40000, Nifty 12000 and Bank Nifty crossed 31500. But party was disrupted as profit booking at higher levels and global upheavals caused a sharp dip from the his as Nifty ended at 11657, down 80 points over vesterday. From the days high, the index lost over 427 points, forming a big engulfing bearish candle.
- Nifty has failed to close above 11800 despite repeated attempts. And with formation of a bearish candle, the minor trend seems to be turning bearish. Over just six trading sessions, Nifty has gained over 900 points with a huge up move. It looks like that a cool off period is setting in whereby the index can experience some corrective action.
- The gap threshold of 11591 is crucial support. The index is expected to violate the support of 11591 and move lower towards 11550 range. The lower gap threshold of 11426 is strong support.
- On the higher side, 11760-11800 remains crucial resistance levels. As the tide has turned, sell on rallies.
