## NIFTY 10343 (48)

Markets had a fairly stable outing today, opening slightly higher and maintaining the momentum. Broader markets outperformed the large cap space. Nifty gained 40 points to end at a new level of 10363.

Some profit booking in the large cap space saw the index ending off the highs, forming a spinning top candle. While the momentum is intact, it seems to have some cool down effect as the index may take a breather at current levels. Already we had seen a minor dip in Nifty which was recovered today but force was missing.

Immediately 10330-10300 is support range while 10370-10400 is resistance level.
