## NIFTY 10343 (48)

Market followed up yesterday's gains to end at fresh new highs. Today being settlement day of the Nov. FnO series, large volumes guided the trend. Nifty ended the day at 10343, gaining 48 points.

Markets are enjoying the flow of positive news flow which continues to propel markets in to newer territory. Displaying strength, Nifty traded above 10300 for most part of the day despite a tepid opening. The index is expected to test 10370 tomorrow. A penetration can push the index towards 10420-10450 range. However, we already have seen a big move in the markets over last four days, hence some minor range bound kind of movement could be seen tomorrow. On the lower side, 10290-10270 is immediate support area.
