NIFTY 10231 (63)

Markets are on a roll. Having zooming strongly over last week, the market opened strong today to touch fresh high. Nifty gained 63 points to end at 10231.

In just three days, the bulls have changed to discourse entirely in their favour, having pulled the Nifty to fresh highs. Third consecutive white candle was formed on the daily chart as Nifty surged to atop 10200 levels emphatically. Such a move along with a breakout gap at 10104-10120 indicates a strong and runaway market. The index may move further higher towards 10375 which is the immediate target post breakout above 10175. In case of any minor consolidation will find 10200 as strong support.
