## NIFTY 9872 (-91)

Markets were battered once again on heavy selling pressure coming from every quarters. Possibilities of rise in Fiscal deficit numbers due yet to announce stimulus package has frightened the players to such a large extent that they have resorted to exiting positions at every level. Nifty dropped to a low of 9816 but recovered partly to end at 9872, losing 91 points over night.

The sequence of large drop is not ending as Nifty dipped to a low of 9816. While it has been almost 350 point fall over last five trading days, host of stocks have seen very sharp losses of over 20% during this period, creating panic.

With decisive violation of the trendline support at 9900, it seems that the intermediate trend has indeed ended at double top of 10170 level and a short term correction has begun which could last for over a month.

Immediately, after witnessing continuous fall for last 5 days, minor pull back can be seen towards resistance of 9900-9940 range. Sustaining higher looks difficult and may invite fresh selling pressure. On the lower side, violation of 9816 would push the index towards 9750-9700 levels.
