COPPER



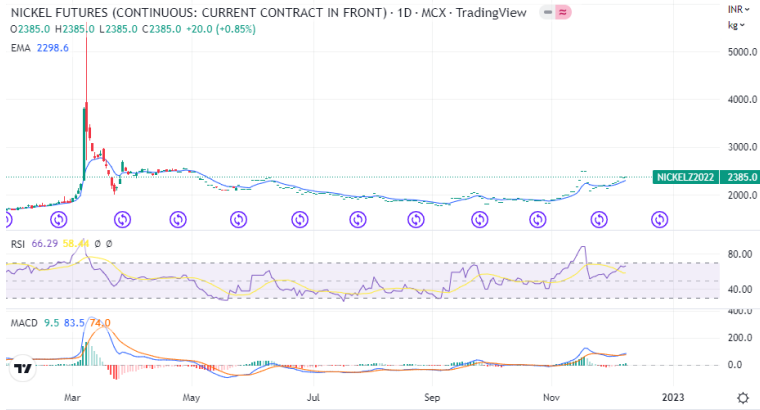
